 European Commission (EC)-funded International Labour Organization (ILO)/ United Nations Children's Fund (UNICEF) joint Project on "Improving Synergies between Social Protection and Public Finance Management"

3. Objectives

- To present to social protection stakeholders the findings and recommendations of the study on extending social protection to the informal economy in Ethiopia.
- Initiate discussions and secure additional inputs to inform concrete recommendations on the operationalization of roadmap post the study.

4. Agenda:

The workshop focused on the following activities:

- Presentation on "Conceptual framework on social protection extension to the informal economy"
- Presentation on the findings and recommendations of the study on "Social Protection Extension to Workers in the Informal Economy in Ethiopia"
- Workshop discussions on strengths and gaps of the study findings.
- Agreement on the way forward and establishment of a task force to guide development of a roadmap to inform implementation of the study recommendations

5. Outcomes of the workshop

The meeting agreed on the following:

- i. Policy revisions to enable social protection extension and formalization of informal economy workers
- This is necessary to accommodate the informal economy in the Ministry of Women and Social Affairs (MoWSA's) upcoming social protection/policy revision
- ✓ This will enable incorporation of the informal economy in future employment policy revisions

ii. Legal Framework

- There is need to incorporate provisions related to informal economy and specifically coverage extension in the labour proclamations
- ✓ Inclusion of and addressing social protection issues of workers in the informal economy in the Trade proclamation

iii. POESSA's institutional preparedness

- ✓ It was noted that POESSA's legal framework has provisions that cover Micro and Small Enterprises (MSEs) and workers in the informal economy
- ✓ POESSA has extended structures from Federal to Regional levels that can be leveraged to anchor coverage extension to the informal economy.
- ✓ Stakeholders that could work with POESSA on the extension of coverage drive were suggested to be MoWSA/BoWSAs, MLSD, CETU, CEEF, Ministry of Revenue, Ministry of Education and Ministry of Health.
- ✓ POESSA would require additional technical support regarding understanding and estimating contributory capacities of various workers so as to inform any pilot exercise on coverage extension ; types of benefit packages to attract workers in the informal economy would require further definition; social security contributions from workers in the informal economy are by law voluntary; a system to collect contributions is not yet in place.

iv. Suggested target groups within the informal economy for piloting social protection coverage extension

- ✓ Micro and Small Enterprises (MSEs)
- ✓ Service sector workers
- ✓ workers manufacturing sector
- ✓ workers in the trade sector
- ✓ Agricultural workers
- The following key recommendations were suggested as a way forward by the workshop participants. This included the establishment of a Working Group comprising of representatives from 11 institutions that were present.

Way Forward

- i. Develop a concise policy brief on extension of coverage for government officials and policy makers
- ii. Establish a platform that works on a step-by-step action plan developed by the Working Group
- iii. Create alliances with key stakeholders including social partners and pursuing social dialogue
- iv. Schedule stakeholders' engagement with view of raising awareness and advocacy on social protection extension to workers in the informal economy
- v. Strengthen the National Social Protection Platform chaired by MoWSA to enhance incorporation of social protection coverage issue
- vi. Conduct more follow-up research and compile evidence to inform policy discussions and decision making
